All permits expire June 30<sup>th</sup> of each year.

\$749.00 Operating Without a License fee will be issued to all facilities, regardless of license category, that are operating without a current permit from this department.

A permit shall not be issued to a new establishment, change in licensee, or if the facility was placed out of business, without a preinspection and payment of applicable fees. Establishments must be properly zoned for the licensable activity. Department of Safety and Professional Services (previously Dept of Commerce) Uniform Dwelling Code (UDC) inspection, Commercial Building Code inspection, well or septic inspection may be required by the Health Department, prior to approval of the application.
